the Swiss Agency for Development and Cooperation (SDC)

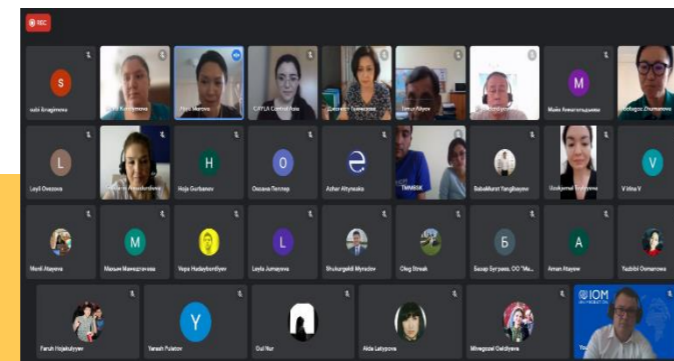
DIASPORA AND COMPATRIOTS DISCUSS WAYS TO PARTICIPATE IN DEVELOPMENT INITIATIVES
